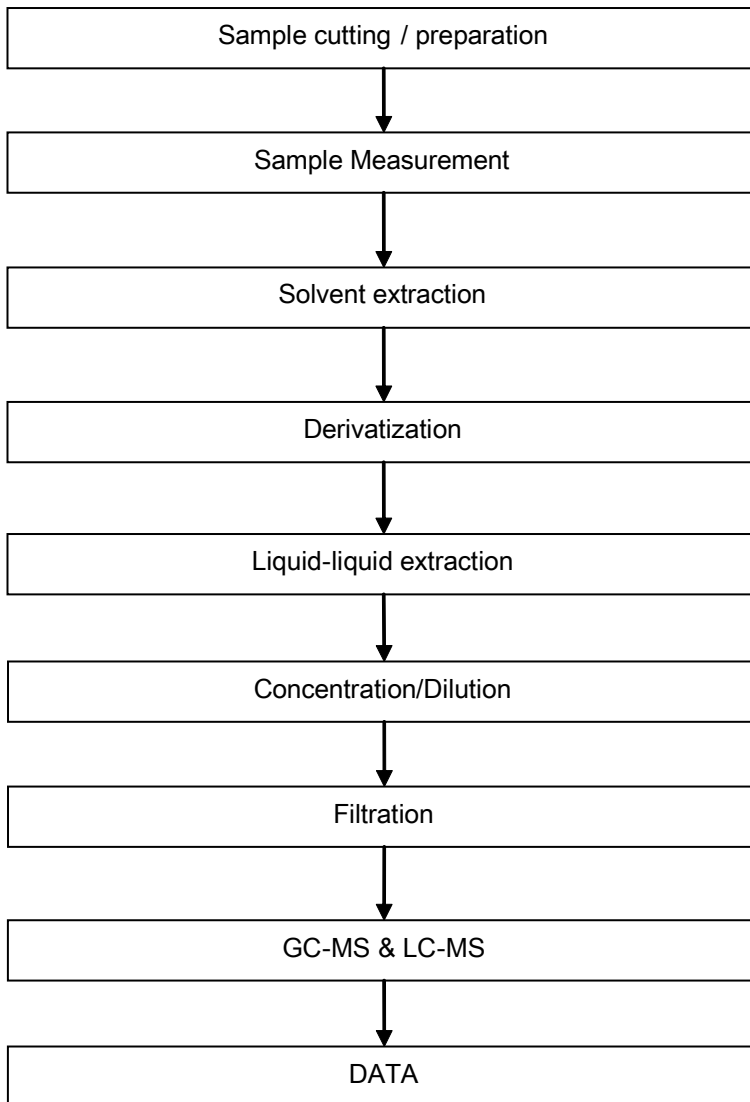

TBBP-A Testing Flow Chart

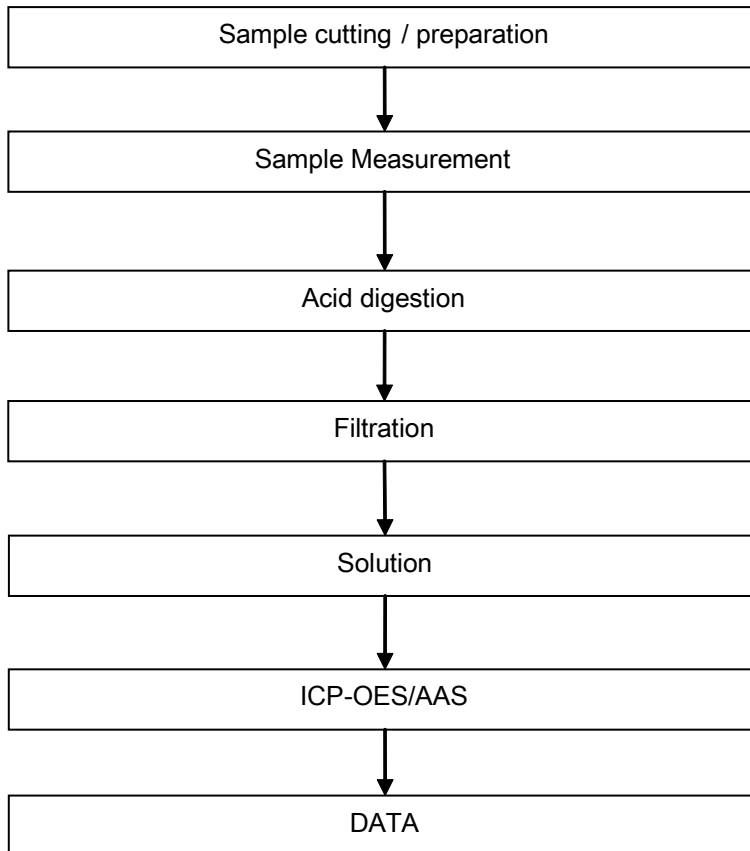

Elementary Testing Flow Chart

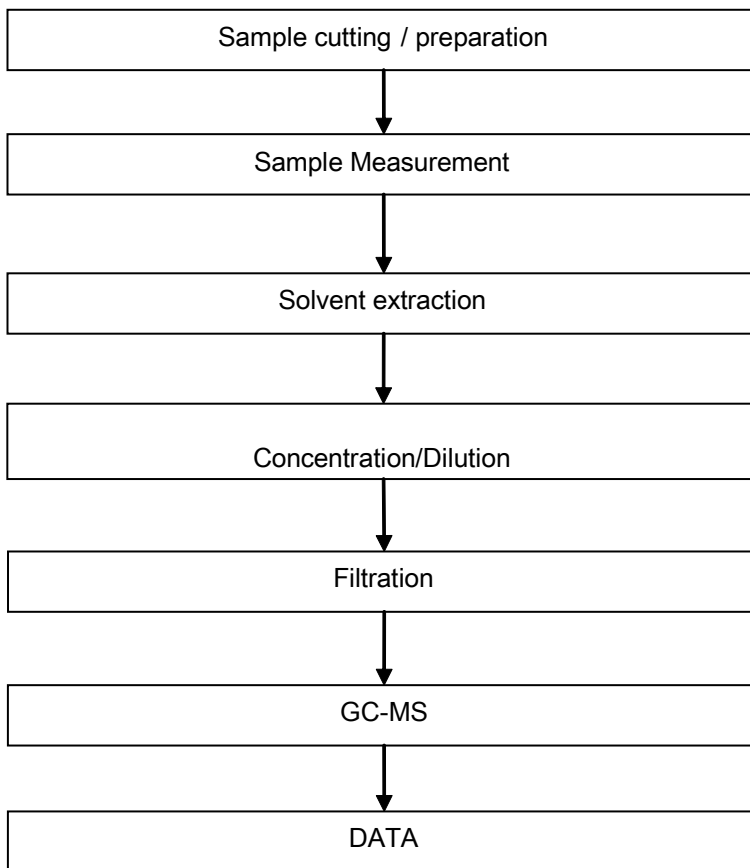

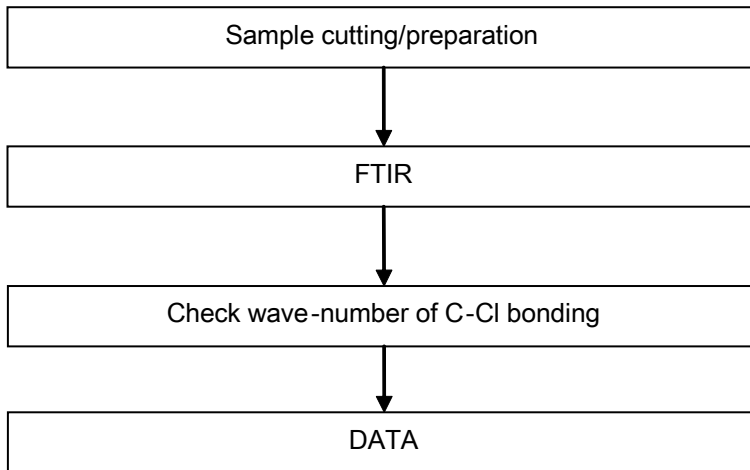

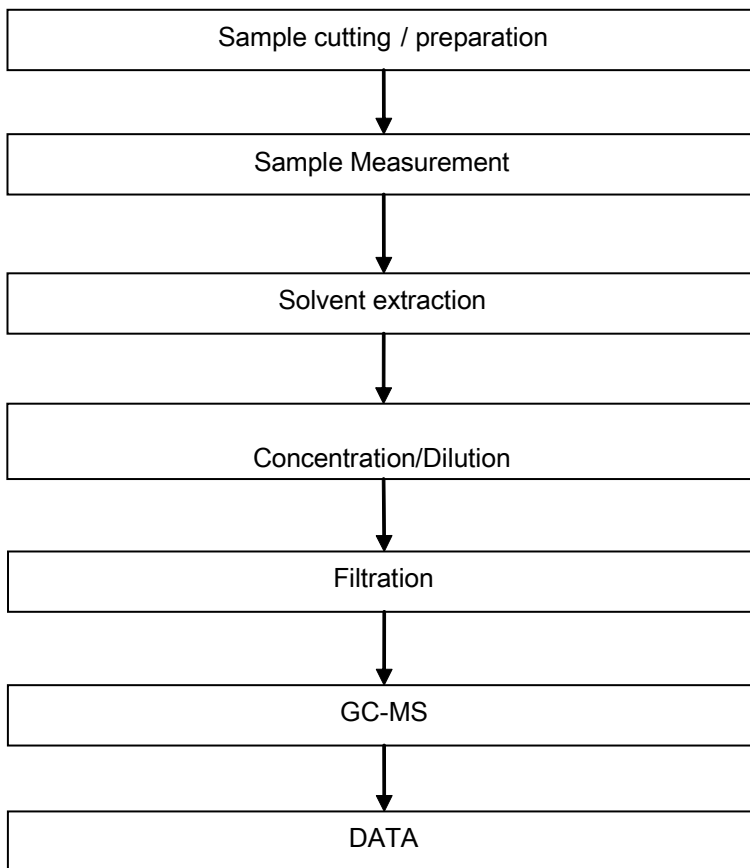

HBCDD Testing Flow Chart

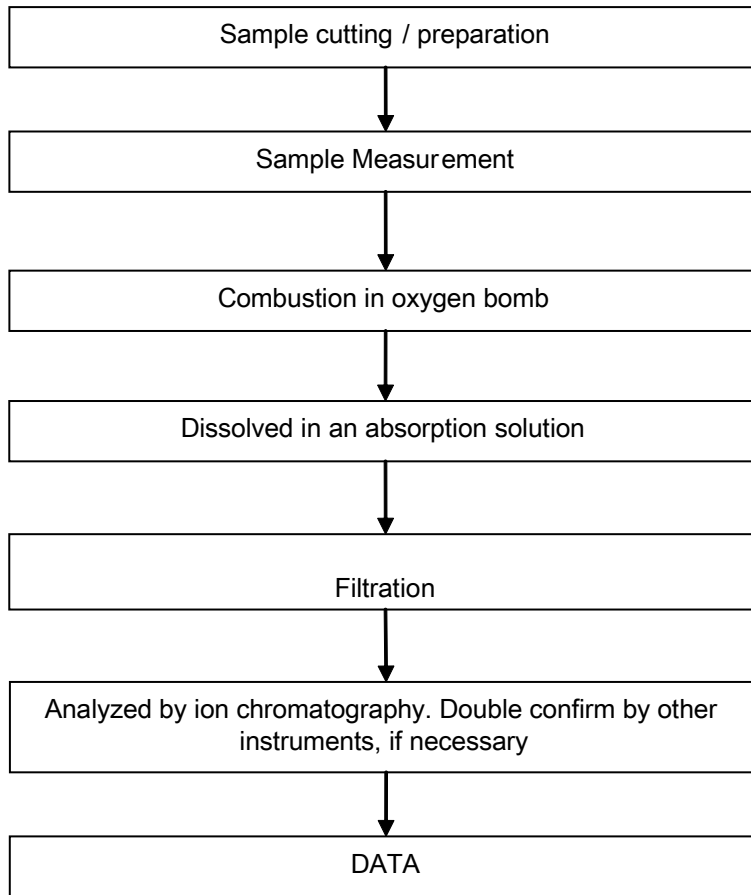

Halogen Testing Flow Chart

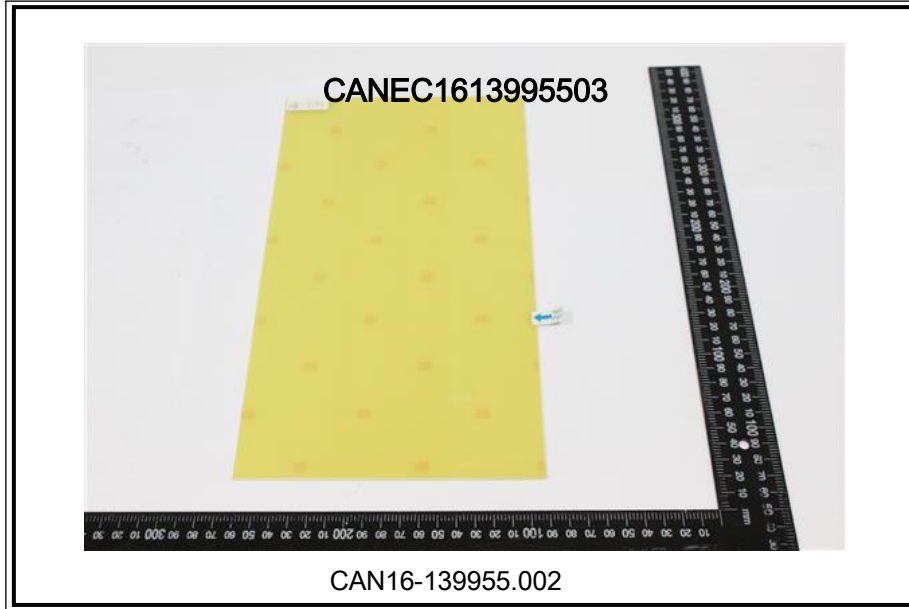
